

KEEPING IN TOUCH

The church would welcome having your name and contact details. This will enable us to keep in touch with you and to provide pastoral support, as appropriate. Data Protection legislation allows us to process this information, as we regard it as being in the church's legitimate interest. All of the information provided is securely stored.

Church Contact List

With your consent, we would also like to add your name and contact details to our Church Contact List. This is published and distributed in both electronic and paper form to all of the Church Members and the Regular Attendees, who have given permission for their personal details to be included. Consent can be withdrawn at any time and details will be removed from the list.

The Contact List is used to provide everyone with regular information about church services, church events and activities, requests for prayer, requests for volunteers, monthly programmes and rotas. Those on the Contact List, who are Church Members, will also receive information regarding church meetings (agendas, minutes and appropriate documentation). Most information is sent by email, but hard copies and telephone calls are available for those with no access to electronic communication.

In order to protect an individual's privacy, it is a requirement that those people named on the Contact List confirm that they will not divulge information to any third party.

Occasionally, we may use personal details and photographs in advertising literature and on our church website. We also require consent before we can do this.
